Profile

The Nishi-Nippon City Bank is headquartered in Kyushu's largest city of Fukuoka, which has a population of approximately 1.4 million. The Nishi-Nippon City Bank Group, centered on the Bank, offers a wide variety of financial services, including credit guarantees and credit card operations. At the end of March 2008, the Bank had a network of 209 branches in Japan. It also maintains representative offices in Hong Kong, Seoul and Shanghai to offer powerful support to customers developing business in the East Asian region.

The Bank has drafted a new medium-term management plan: "New Stage 2008." This plan marks the first step toward a new stage for the Bank's evolution. Through the practice of relationship banking, we make top-level services available to our customers in Kyushu, and aim to become Kyushu's No. 1 bank, prospering together with our customers. In our new medium-term management plan, we are targeting sustainable growth with a priority on meeting customer needs and expanding profitability.
